

UNIVERSITY OF COLORADO AT BOULDER ATHLETICS BOARD (CU-BAB)

The CU-BAB serves as an advisory committee to the Chancellor and Provost for all matters relating to the Department of Intercollegiate Athletics, including budgets and business planning, space planning and capital construction, strategic planning, student-athlete services, athletics summer camps, personnel, and other policy and operational matters, as appropriate. The CU-BAB monitors and has oversight of all academic support programs and academic policy implementation for student-athletes and other affected students. The CU-BAB shall participate in the development of the self-study for NCAA certification, and shall review and approve the self-study before it is forwarded to the NCAA. As the advisory committee, the CU-BAB shall receive reports at least annually from Athletic Department personnel on all matters within the Board's charge, and may request special reports as necessary. The CU-BAB may recommend academic and scholastic policy modifications to the BFA for its consideration, and other policy modifications to the Athletic Director and Provost. The CU-BAB reports to the Provost, and to the Chancellor as appropriate, and shall make a report at least annually to the BFA.

In addition to the above, the CU-BAB has specific responsibility for:

- Approving student-athlete handbooks and conduct policies;
- Monitoring all recruitment activities, including compliance with UCB policies and NCAA regulations;
- Monitoring implementation and adherence by the Department of Intercollegiate Athletics to all UCB policies, especially those affecting student-athletes and other students involved in athletics programs;
- Monitoring Title IX issues, and matters of gender equity as they affect student-athletes and Athletic Department personnel;
- Communicating and coordinating with the BFA Intercollegiate Athletics Committee in all appropriate areas, including but not limited to matters of entrance level test scores of student-athletes (SATs, ACTs, etc.), student-athletes' progress towards degrees and grade point averages, and student-athlete graduation rates;
- Providing oversight of any internal investigation of violations of NCAA, Big 12 Athletic Conference, or other oversight organization's rules, and periodically reviewing the processes developed to manage the internal investigation and resolution of potential major and secondary infractions of NCAA, Big 12 Athletic Conference, or other oversight organization's rules.
- Providing one or more members as campus representatives to participate to the full extent permitted and appropriate in investigative proceedings of the NCAA, the Big 12 Athletic Conference, or other oversight organizations, for infractions of governing rules;
- Monitoring the implementation of any penalties imposed by the NCAA, the Big 12 Athletic Conference, or other oversight organizations, for infractions of governing rules.

The Chair of the CU-BAB shall serve on the Compliance Committee, as convened by the Faculty Athletics Representative or other official.

Membership of the CU-BAB shall be as follows:

- At least seven faculty members, of whom four shall serve on both the CU-BAB and the Boulder Faculty Assembly IAC;
- One or more student representatives, including at least one student-athlete;
- One or more administrators, including an administrator from the office of the Vice Chancellor for Student Affairs;
- One or more administrators from the Athletic Department, preferably including a head coach for a varsity sport.

The maximum size of the CU-BAB shall be 13 members, including the Chair. The Chair of the CU-BAB shall be a faculty member. Faculty members of the CU-BAB shall serve for two-year terms; term lengths for other members shall be determined by the Provost.

CU-BAB members and the Chair shall be appointed by the Provost, except for the two members from the BFA IAC (who shall be full voting members of both committees) and the Chair of the IAC, all of whom are appointed by the BFA. The Chair of the BFA IAC shall serve, *ex officio* with voting privileges, as a member of the CU-BAB. The Faculty Athletics Representative shall serve, *ex officio* with voting privileges, as a members of the CU-BAB.
